

PROGRAMME FOR THE 2nd AFRICAN SCHOOL ON INTERNET GOVERNANCE - Mauritius, 21-25 November 2014

Overview of curriculum content: AfriSIG 2014 cover the following main themes:

- Theoretical concepts and principles: including human rights, history, politics, and law relevant to Internet users and intermediaries
- Technology and the governance and management of critical Internet resources
- National and regional policy: including convergence with telecommunications policy and regulation
- The Internet Governance landscape in Africa

Participants: We are expecting around 45 participants from all over Africa. Some West African countries are not represented as a result of the Ebola-related travel ban to Mauritius. Participants are from civil society organisations and governments, including national communications regulators. Some are entrepreneurs, and some work in Internet organisations. Many would be new to Internet Governance-specific debates. As they have had to compete to be accepted (the 45 were selected out of more than 600 applicants) we believe they are eager to learn and participate.
